I. Recaps of Past Event and Projects:

- a. Cherry Street Soiree en Blanc 350+ people in attendance. Committee member asked if it could be expanded to include all of E. Cherry Street.
- b. ArtsFest Committee member asked about there being higher end art possibly placed in the foyer of UCPAC.

- d. Paint Rahway Pink
- e. SID Business Improvement Program and Façade Improvement Program Update No business have received funding during the past two months. The SID is still working with a few businesses to complete their funding requests.
- f. Public Art Update
 - i. Public Art Incentive Program Quilla is the first to apply and we are working with them to have a mural painted on their building
 - ii. 2255 Elizabeth Ave Mural has been completed and there will be a dedication ceremony held later in the month

 - iii. Rocks/gravel by E. Cherry Street mural are being thrown and could end up damaging the mural.
